(Note that these 2008 guidelines are roughly equal to the poverty thresholds for calendar year 2007 which the Census Bureau expects to publish in final form in August 2008.) The guideline figures shown represent annual income. For families with more than 8 persons, add \$3,600 for each additional person.

Annual Update of the HHS Poverty Guidelines - Federal Register

Include a joint sponsor whose income and/or assets equal at least 125 percent of the Federal Poverty Guidelines. The goal of the I-864 Form is not to eliminate low-income immigrants but to ensure that such immigrants, once admitted to the U.S., do not become a burden to the social services system.

To prove that you are wealthy enough to sponsor this person, you have to fill Form I-864 (Affidavit of Support). During filling this form, applicant has to prove that he or she is above a standard of the poverty guidelines, as defined under Section 213A of the Immigration and Nationality Act.
