A couple who have joined in a common law marriage may subsequently make a Declaration of Marriage without Solemnization, MCA 40-1-311, which can then be filed with the Clerk of the District Court and would "serve as an official record of the marriage of the parties." MCA 40-1-402. Such a Declaration does not make the parties' prior common law marriage less valid; it just is proof positive which may make some transactions of adult life easier.

If you are in a state that recognizes common law marriage, you can show proof of your common-law relationship by providing an affidavit from you and your partner regarding your history together.

The complete, notarized affidavit along with the enrollment change forms must be completed and returned to the Human Resources Associate within 30 days of the date of hire or the date for the common law marriage, whichever is later, in order to add the common law spouse to the existing coverage.

For those who are currently incarcerated within the Texas Department of Criminal Justice and have not declared their common law marriage with the county clerk, both the incarcerated person and the common-law spouse may submit to the warden an Affidavit of Informal Marriage form declaring the marriage.
