IV. Training and Education. DU will conduct periodic training on an ongoing basis with the twin goals that: (1) all employees will receive training on how to perform their jobs in compliance with the standards of DU and any applicable regulations; and (2) each employee will understand that HIPAA compliance is a condition of continued employment.

The HIPAA Security Rule mandates that every practice or health care organization that creates, stores, or transmits ePHI, must designate a privacy compliance officer regardless of their size. In larger firms there will typically be a dedicated HIPAA privacy officer, however in smaller firms the role might fall on an employee with administrative or IT responsibilities as well.

The RA is required by the HIPAA Security Rule and should not be skipped by the privacy professional, just because the RA is a "security thing."
