The basic rule for refurbished goods is that once a product is returned, it cannot be sold as new, even if the product was never used. So, any of these items may be lawfully sold as "refurbished" for a fraction of the cost of

It's illegal for a dealer to sell you a damaged vehicle without disclosing the car's condition, but some do. Yes, the Supreme court case and the owner's rights initiative are about selling items you lawfully purchased and own. In addition, there is an endless list of items that are prohibited to sell on Amazon, and it includes things such as drugs, weapons, fine art, cosmetics, and animals.

Title jumping is illegal in every state. Even if you purchase a vehicle and turn around the next day and sell it, you are legally required to transfer the title into
