Evidence of self or parents or grandparents, Being eligible to become a citizen of India at the time of Commencement of the Constitution or Belonging to a territory that became a part of India after 15th August, 1947; or Being a citizen of India on or after 26th January, 1950.

Up to the completion of 20 years of age, OCI documents will have to be re-issued each time a new passport is issued. Between 21 to 50 years of age, you are not required to seek re-issuance of OCI documents each time a new passport is issued. However, if you like, you can use this service for re-issuance of OCI documents.

Important note for all OCI Applicants (Mandatory): Applicants are required to submit the originals along with a set of photocopies of the originals, both sets of documents need to be submitted at the counter. Originals will be returned once the High Commission of India and its respective Consulates are satisfied with the documents provided.

Overseas Citizenship of India (OCI) Checklist

Overseas Citizenship of India is granted to applicants who have acquired citizenship of a foreign country and who were of Indian Origin, or were or are eligible to become a citizen of India, or are a spouse of an OCI / PIO Holder or a spouse of Citizen of India. Under the Indian Citizenship Act, persons of Indian Origin are not allowed to claim dual citizenship.
