CONTRACTOR'S FINAL RELEASE AND WAIVER OF LIEN

Once a contractor executes a final waiver and release of lien, they are releasing all lien rights against a potential owner. For this reason, contractors should condition the final waiver and release on clearance of funds as provided in Fla Stat. § 713.20(7). This protects contractors in the event a check does not clear.

Conditional and Unconditional Waiver and Release Forms

unconditional waiver and release on final payment notice to claimant: this document waives and releases lien, stop payment notice, and payment bond rights unconditionally and states that you have been paid for giving up those rights, this document is enforceable against you if you sign it, even if you have not been paid.

A lien release is used to cancel a lien that has already been filed. It's most often used to release a lien claim after a lien claimant receives payment.
