A Special Provision in 2010 TRA 2010 made a special provision for the generation-skipping transfer tax for the 2010 tax year. Although the tax wasn't abolished and the exemption amount increased to \$5 million that year from \$3.5 million in 2009, the tax rate was temporarily set to zero.
