Most visitation schedules provide for visitation on the first, third and fifth weekends of the month. This can get very confusing because the weekend begins on Friday and some months have a fifth weekend which means that there are back to back weekends of visitation. The following calendars show the first, third and fifth weekends of each month. Remember that holidays take priority over weekend visitations.

Calendar of First, Third and Fifth Weekends - The Texas ...

Under an extended standard possession schedule, the non-custodial parent can have visitation on the first, third, and fifth weekends of the month, starting on Thursday at either the time school lets out or 6:00 p.m. and ending on Sunday at 6:00 p.m. or at the time school resumes on Monday morning.
